FMU invites bids (technical and financial proposals sealed in separate envelopes) from eligible bidders for “**Procurement of Technical IT Hardware & Software Trainings**” as per details mentioned in the “Technical Specification” in the Bidding Documents.

Bidding will be conducted under Open Competitive Bidding pursuant to ‘Single Stage Two Envelopes procedure’ as per Rule 36(b) of Public Procurement Rules (PPR) 2004 and is open to all eligible Bidders as defined in the PPR 2004 that meet the following minimum eligibility/qualification criteria

1. *Not blacklisted under the provision of Rule 19 of Public Procurement Rules 2004*
2. *Bidder must have experience of providing or arranging at least 5 international and 10 local similar trainings in the last year.*
3. *Bidders must be registered with the concerned Federal and Provincial Tax Departments and must also appear on the Active Tax Payer List (ATL) of the FBR, Pakistan.*

Technical details of the training should be provided with the bid.

The Bidders are requested to give their best and final prices as no negotiations are expected. The rates quoted must remain valid for a period of 90 (Ninety) days after opening of bids.

Interested eligible bidders are required to obtain an electronic (soft) copy of the bidding documents upon submission of a written application to the address below & upon cash payment of a non-refundable fee of Rs.1,500/- (one thousand and five hundred only), during office hours after publication of this IFB till closing thereof. This IFB is uploaded for display on the websites <http://www.ppra.org.pk> and <http://www.fmu.gov.pk>. Bidder shall bring along a USB flash drive to obtain the soft copy of the bidding documents. Bids shall only be accepted from those bidders who accordingly obtain an electronic copy of the bidding documents.

Bid security of not less than **03%** (three percent) of the bid price must be accompanied with the bid in a separate sealed envelope. Bidders have to submit bids for **COMPLETE REQUIREMENTS**. Late bids will be rejected. Bids submitted without signed Bid Form by authorized nominee of the bidder will be rejected. Bid with material deviation, exception, objection, conditionality, or reservation will also be rejected.

Bids must be delivered at the office of the undersigned on or before **Monday, May 07, 2018 at 10:00 AM**. Bids will be opened, in the presence of bidders’ representatives who choose to attend, at 10:30 AM same day at FMU Office.
